THE SOCIETY'S POLLINATOR CONSERVATION PROGRAM WORKS ACROSS THE UNITED STATES TO EDUCATE FARMERS, LAND MANAGERS, AND THE PUBLIC ABOUT THE IMPORTANCE OF POLLINATING INSECTS AND TO ESTABLISH HABITAT PROTECTION AND MANAGEMENT AS KEYS TO THEIR CONSERVATION. IT DIRECTLY REACHES AGRICULTURAL PROFESSIONALS AND FARMERS THROUGH TRAININGS, WORKSHOPS, AND OTHER OUTREACH EVENTS ACROSS THE UNITED STATES. THE SOCIETY'S ENDANGERED SPECIES PROGRAM ADVOCATES ON BEHALF OF THREATENED, ENDANGERED, AND AT-RISK INVERTEBRATES AND THEIR HABITATS AND WORKS WITH AGENCY STAFF TO PROVIDE RESOURCES AND TRAINING FOR THEIR CONSERVATION. ITS CURRENT WORK INCLUDES EFFORTS TO PROTECT ENDANGERED BUMBLE BEES, BUTTERFLIES, FRESHWATER MUSSELS, TIGER BEETLES AND OTHER INVERTEBRATES. THE SOCIETY PROTECTS HABITAT ON PRIVATE AND PUBLIC LANDS FOR THE MOST IMPERILED SPECIES AND REGULARLY PROVIDES RESOURCES THAT HELP LAND MANAGERS CONSERVE ENDANGERED INSECTS AND OTHER WILDLIFE.
